E-BIKE RENTAL REGULATION

The rental and use of the pedal-assisted bicycle presupposes the knowledge and unconditional acceptance by the user of this regulation, rates, opening and closing times of Altravista Wheel srl lessor of the asset, based in via Dell'Artigianato, 47 in Melara (RO) cap, 45037 - PI: 01542310295.

- 1) The Renter (User) declares to collect the bicycle and all the eventual rental extras in perfect condition and maintenance. Any damage must be described in the appropriate box (see below).
- 2) To obtain the rental of a pedal-assisted bicycle, the user must present in advance to Altravista Wheel a valid identity document or driving license: these documents will be retained by the manager until the end of the rental.
- 3) The use of the E-Bike bicycle presupposes the physical fitness and technical expertise of those who intend to ride it. Therefore, the user renting the bicycle declares to have adequate capacity and appropriate competence, without placing any reservation. In the case of use by minors with the signing of this contract, the parent / custodian or guardian of the minor assumes all the responsibilities indicated in this contract and by the civil code, and consequently authorizes the minor to use the bicycle under the conditions provided for in this regulation.
- 4) The bicycle is to be used exclusively as a means of transport and the Renter is expected to look after the vehicle as a decent and careful owner with care and diligence, particularly making sure that the vehicle is not used to carry persons or property for hire transferring use to other subjects, or carrying out commercial activities.
- 5) The user is responsible for the electric bicycle until it is returned to the Lessor; He is also responsible for damage caused to himself, his bicycle, third parties and things during the use of the vehicle. No form of compensation can be requested from the Lessor. The user with the material apprehension of the asset becomes the guardian of the bicycle for all legal purposes and declares to indemnify and hold the property harmless from any claim for compensation that may be received.
- 6) The rental does not include any form of insurance for the User nor the electric bicycle is covered by third party liability insurance. The user is therefore required to comply with the traffic regulations. The Lessor declines any form of responsibility in case of improper use of the vehicle or failure to comply with the rules of the road code.
- 7) The Lessor may carry out checks on Users during the use of bicycles and may request at any time their immediate return if it deems the conditions of improper use of the vehicle. The Manager may refuse the rental to people in a state of drunkenness or under the influence of drugs (in accordance with articles 186-187 of the road code) and for other reasons at the sole discretion of the Lessor himself.
- 8) In case of loss of keys, bicycle accessories or damages, the Lessor will request from the Customer the funds necessary for the restoration of the bicycle to original conditions, based on what is indicated in the price list in force of the bicycle supplier; in case of total theft, the renter will be charged a fee of € 1.500,- for each bicycle.
- 9) The bicycle must be returned, in compliance with the times indicated in this contract, in the same place where it was rented. The bicycle is considered returned only if returned directly to the Rental Manager with the countersignature of the return on the contract; The parking of the electric bicycle outside the rental point during closing time cannot be considered a return. Failure to return the bicycle without prior notice or in any case not motivated by exceptional cases, will be considered as a crime of theft and therefore reported to the Judicial Authority.
- 10) The User must pay the relevant payment from the time of the start of the rental until presentation for closing of the rental contract, in addition to any charges for damage, total or partial theft.
- 11) In case of theft of the electric bicycle, the User must submit to the Rental Manager a copy of the report made to the competent authority and pay the amount equal to the value of the stolen bicycle (see Art. 8), which will be returned to him in case of found or recovery of the vehicle itself.

For further provisions not mentioned in this regulation, the relationship between the Parties (contracting parties) is governed by the rules of the Civil Code. For any dispute arising between the Parties, the competent court is elected in Rovigo.
